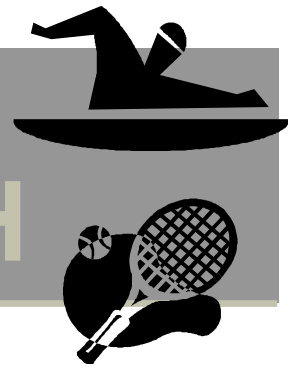

- Early Bird Registration:** Sunday, March 29th from 3 p.m. until 5 p.m. at DNDC clubhouse
Open to all returning swimmers/families and to all DNDC members
Reduced registration fee of \$80/swimmer with a \$200 family max
- Open Registration:** Thursday, April 23rd from 6 p.m. until 8 p.m. at DNDC Clubhouse
Open to all returning swimmers/families and to all DNDC members
Open to nonmembers if space is available with an additional \$50 fee per swimmer
Registration fee of \$85 per swimmer with a \$215 family max
- Late Registration:** After April 23rd, contact Kristie Van Winkle at kvanwinkle@bellsouth.net or at 770-455-6275. Registration fee increases to \$90/swimmer with a \$230 family max.
