BY-LAW CHANGE INFORMATION:

At our June meeting we discussed two things regarding membership that require changes in the existing By-Laws. First, there is the question of who can be a member of the Dunwoody North Civic Association, and second, is the amount of annual dues. The By-Laws also state that such amendments must be submitted in writing to all members at least ten (10) days before such meeting.

The By-Laws state in Article III, Membership.

Section 1. Membership of this corporation shall be limited to one (1) adult member of each family owning a home in the subdivision known as Dunwoody North, DeKalb County, State of Georgia.

Section 3. The annual dues shall be Five Dollars (\$5.00), payable from the 1st to the 15th of September.

The consensus at our last meeting was to include residents of Andover Estates, Dunwoody Trails, Brafferton Square, and Briars Trail as part of our Civic Association and to raise the annual membership dues to \$10. To do this requires the following changes to the By-Laws, Article III, Membership.

Section 1. Membership of this corporation shall be limited to one (1) adult member of each family owning a home in the subdivision known as Dunwoody North, and homes in the adjacent subdivisions of Andover Estates, Dunwoody Trails, Brafferton Square, and Briars North, DeKalb County, State of Georgia.

Section 3. The annual dues shall be Ten Dollars (\$10.00), payable during the month of September.
