

# Winter Pet Care

In Georgia, it is not uncommon for people to leave pets outside for long periods of time. Since our climate is generally mild, many people believe that pets are happier outdoors. Many cats enjoy being outside; they can safely enjoy the outdoors from a "catio" ([www.catiospaces.com](http://www.catiospaces.com)). Some dogs enjoy being outside for longer periods of time, especially if they have another dog to play with, and adequate food, water, and shelter. Georgia has, however, been having some freezing days and nights recently; some days are deceptively cold, even when the sun is shining. Our pets DO get cold, and they suffer from a variety of cold related ailments. Also, today's domesticated dogs and cats are not wild animals; if it's too cold for us, it's too cold for them.

GA law does not spell out the type of shelter that is required, but clearly states that it is against the law to cause suffering to an animal by an act of omission. Dunwoody has much more specific ordinances:

*Adequate shelter* means a protective covering for a domestic animal that provides adequate space and protection to maintain the animal in a state of good health, and that prevents pain, suffering, or significant risk to the animal's health. Adequate shelter shall consist of a completely enclosed structure with four sides, a constructed floor, and a roof with a door opening. It should also be clean, dry and compatible with current weather conditions, in addition to age, size, species and condition of the animal. The structure should be of sufficient size to allow the animal to stand, turn around, lie down and go in and out of the structure comfortably. To be adequate, some type of bedding that is quick drying, such as hay or pine straw, must be provided to maintain comfortable temperatures within the structure during times when the ambient, outside temperature is below freezing. In addition, the structure shall include a heavy plastic or rubber flap to cover the door and/or window openings during the months of November through March. From April through October, the structure shall either be shaded or moved out of direct sunlight. If the shelter is made of wood, it shall be raised at least two inches off the ground to prevent seepage or rotting. Examples of inadequate shelter include, but are not limited to, lean-tos, metal or plastic drums, boxes, abandoned vehicles, porches, decks, or material that does not provide sufficient protection from the elements.

If you see an animal suffering in extreme weather, and a gentle reminder to the pet's family does not improve the situation, you can report the situation to DeKalb County Animal Services: Telephone: **404-294-2996**

Be sure to take photos, and note the times that you witnessed the situation.

For those of you who don't already know, I'm Judy Millner-Hofer and I have succeeded



Lisa Dirks-Unkefer as the new Neighborhood Watch Chairwoman. We thankfully continue to live in a peaceful and safe community with only one 2015 incident, which I just read about in the newspaper. This incident appears to be a possible car break-in, but I am inquiring about it, as no one called me. Nonetheless, that is a phenomenal record! In the event of any criminal activity, first call 911 and then please call me (404) 402-9354. I can also be reached by email: NeighborhoodWatch@DunwoodyNorth.org or jrmh@bellsouth.net.

I am beginning to re-establish the neighborhood Watch organization, although I envision it working slightly differently. I have eliminated the supervisors, as an unnecessary organizational layer, and will ask the block captains to collect current resident data on information sheets I will provide them. After they return those sheets to me, I will enter the data and return the updated sheets back to the block captains. The block captains will then fill out an individual sheet for each of the residents on their list and distribute them directly to the residents. These sheets will contain the resident's four immediate neighbors and their contact information on one side, and general Neighborhood Watch information on the reverse side. We will only ask the block captains to do this once a year. After that, their only activity will be to notify me directly, if there is any change in the information.

My predecessor did a wonderful job creating a large organization, over 40 block captains, but after so many years, many of the existing block captains may no longer be willing or able to continue. Consequently, if you are an existing block captain and no longer want to be, please call me and let me know, so I can recruit someone else. Also, if you are interested in getting involved, there is no quicker way to meet your neighbors than to knock on their door and introduce yourself as a block captain.

We particularly need volunteers on Brookhurst Drive, Huntington Circle, Vintage Lane, Kingsfield Court, E. Kingpoint Rd, Ledgewood Dr., Norwalk Rd., Riverglenn Circle, Riverglenn Court and Stonington Rd. If you live on any of these streets and would be willing to be a block captain, please give me a call.

# DNCA MEMBERSHIP UPDATE





blossoming. It is nice to have the flowers now, but we may pay with less color in the spring. One plant that is blooming at the appropriate time, and is an excellent choice for our shady Dunwoody North landscapes, is Hellebore Orientalis, commonly known as the Lenten rose. This plant, which is actually in the buttercup family, is a perennial that thrives in partial to full shade and is deer proof. We have seen blooms starting as early as December and continuing through winter into spring. The blooms range in color from white to pink, rose and magenta. There are so many interesting varieties out there, you are sure to find one that compliments your garden. The Lenten Rose will drop seeds and spread, creating a lush ground cover. You may even find a neighbor who is thinning out their bed and is willing to donate a few plants for you to transplant.
