# DUNWOODY NORTH NEIGHBORHOOD WATCH

### **REVERSE 911**

Reprinted from Dekalb County Safety Community Relations Unit-Neighborhood News...

COUNTY POLICE TO RING PHONES IN DeKalb HOMES- Don't be alarmed if Public Safety Director, Thomas Brown, calls you at home, as you won't be alone. Director Brown-or rather a computer with a recorded message from the Director will start dialing DeKalb County residences and businesses in the months to come.

This is part of a new community notification system designed to arm citizens with information to keep from becoming crime victims and to ask them to help police locate criminals. The computer can be programmed dial residents county wide, individual neighborhoods, business owners, or The Neighborhood Watch Block Captains/Coordinators to deliver taped messages.

The system can also be used to answer incoming calls 24 hours a day from citizens interested in police information and community programs. This system is not in service currently. No beginning date has been announced. More details will be shared whenever they become available.

### WHEN SHOULD YOU CALL THE POLICE?

Call the police immediately about all suspicious activity, and do it yourself! Don't worry about bothering them-that's what they are there for. Don't worry about being embarrassed if you are wrong - think about what might happen if you aren't and you don't call....

#### WHAT CONSTITUTES SUSPICIOUS BEHAVIOR?

Basically, anything that seems even slightly out of place or that occurs at an odd time of day could be criminal activity. Some of the most obvious are:

- A stranger entering a neighbor's house when it is unoccupied may be a burglar
- A scream could mean an assault or robbery
- Anyone removing accessories, license plates or gasoline from a car should be reported
- Anyone peering into parked cars may be looking for valuables on display or a car to steal
- The sound of breaking glass or loud explosive noises could mean an accident, housebreaking or vandalism
- Someone going door-to-door. Watch them for a while. If after a few houses are visited, one or more persons tries a door to see if it is locked or goes into a back or side yard, they could be a burglar.

### DUNWOODY NORTH CIVIC ASSOCIATION SIGN COMMITTEE UPDATE


Phase I of the committee plan has been completed. The sign committee reviewed pictures of entrances to other Dunwoody neighborhoods and considered the building styles in Dunwoody North. They settled on the design below; both because it met the style criteria and it gave the neighborhood the most "bang for a buck".

See the picture for a description of the sign. Additionally, the plan is to put two signs on North Peachtree at each end of the neighborhood and two on Tilly Mill at Stonington and either Binghampton or Laurelwood.

#### Plans for Phase II are:

- 1) Obtain permission from property owners of potential sites to erect signs.
  - \* If you are a home owner who would allow a sign and are one of the locations above, please call the sign committee.
- 2) Obtain drawing of signs and elevations on sites.
- 3) Run through Dekalb Co. approval process.
- Start funding drive.

\* Checks should be made out to Dunwoody North Civic Association with "Sign" in the memo section. There are more than 600 homes in Dunwoody North. The sign committee was formed by the Civic Association, it is hoped all members will donate to the signs. All non-member donations will be greatly appreciated also.



The signs are brick with an attached face similar to the DNDC sign. This design is very low maintenance.

Sign dimensions are 4' x 4' x 6'

They are to sit off center with one corner nearest the street and will have faces on two adjoining sides of each.

Dear Ms. Penn,

The Division of Environmental Health of the DeKalb County Board of Health is requesting your assistance in providing radon tests for residents of DeKalb County. Through your cooperation, we would like to provide testing and increase awareness of health risks associated with longterm radon exposure in your community.

Radon is the second leading cause of lung cancer in the United States - only cigarette smoking causes more lung cancer deaths. To address this health issue, the Board of Health provides both short-term and long-term Radon tests at no expense to DeKalb County homeowners. To request radon testing, the homeowner must complete a request form and return it to the Board of Health. An inspector will contact the homeowner to discuss radon testing procedures.

Enclosed please find copies of the request form (duplicate as needed). Your assistance in with the distribution of the request forms in your community is vital in reducing the risk associated with long-term radon exposure.

Dear Ms. Penn:

As you are aware, I have opposed the closing of the Brook Run Center for the Mentally Retarded in Dunwoody, Georgia. This critically acclaimed institution was "de-funded" by Governor Zell Miller and is now slated for closure as of December 31, 1997.

It saddens me to report to you that eight patient deaths have been reported to my office. These deaths all occurred in a period of less than six months. The report of the deaths alarmed me and I felt compelled to call for Federal intervention into the closing of the Brook Run facility. While we have not received an official response from U.S. Department of Health and Human Services Secretary Donna E. Shalala, we are pressing for a HHS investigation to the procedures the state of Georgia is using to close the facility. Also, in light of the deaths, I have requested that the Medicaid waiver needed to close the facility be held up unless and until the issues I have addressed are answered.

In an effort to keep you informed of our progress, I am enclosing the letters that I sent to Governor Zell Miller and to Secretary Shalala regarding the closing of Brook Run. While we may not be able to totally block the closing of this much needed facility, we can at least try to force the state to come up with a thoughtful and acceptable closure plan - a plan acceptable to the parents of the patients at the Brook Run facility.

Please know that I am very sensitive to your concerns and will work with you in any way possible.





## **Update on Ashton Woods**

BMR Development has begun work on the Ashton Woods Subdivision on Tilly Mill between Briers North and Laurelwood. Unlike previous developers, BMR was willing to work with Dunwoody North and adjacent property owners in Briers North on a long list of conditions. Dunwoody North was able to use the R-75 zoning category to set a precedent to preserve "low density residential" land use all the way down to Doraville. Prices for these homes are expected to start in the 230's.

On July 22, the DeKalb County Board of Commissioners approved another rezoning to R-75 with a similar list of conditions for the Hunter and Marshall properties, across Tilly Mill from Ashton Woods. The vote was 6 to 1 in favor of the conditional rezoning. The developer is BMR, again, and this property is expected to be developed as a "phase 2" of Ashton Woods. Conditions are very similar to those on "phase 1", except that most lot sizes will be over 15000 square feet. Therefore, density will only be about 2.8 units per acre! Prices will start in the mid-200's.

This assemblage includes some currently undeveloped property fronting on Sharon Valley Ct. Two new houses will be built facing Sharon Valley, which will not be part of Ashton Woods. They will be developed compatibly with the Dunwoody North community. The zoning on these 2 lots was not changed from R-85.

The precedents that have been set will likely bring additional redevelopment on Tilly Mill. The conditional R-75 zoning is far less dense than the previously proposed R-50. The many conditions that have been granted, as well as the expected price range, should mean desirable redevelopment, and hopefully higher property values for all of us.
