HOLIDAY SAFETY TIPS

(From the Community Relations Unit of the Dekalb Public Safety Department)

This holiday season, don't let the spirit of giving lull you into giving burglars, muggers, and pickpockets a better chance to do their dirty work. Here are some tips on how to celebrate safety this holiday season:

- If you are traveling:
 - -get an automatic timer for your lights
 - -ask a neighbor to watch your home
 - -park a car in your driveway
 - -have a neighbor/relative pick up your mail
 - -consider a house sitter
- If you're out for the evening:
 - -leave on lights and radio in your absence
 - -lock all doors and windows if you leave even for a short time
 - -don't display gifts where they are visible to the outside
- If you're shopping:
 - -stay alert-be aware of what's going on around you -park in a well-lighted area, lock all doors and windows-keep all purchases in trunk
 - -avoid carrying large amounts of cash: use a check or credit card if possible
 - -don't overburden yourself with packages-be extra careful with wallets and purses
 - -shopping with kids? teach them to go to a store clerk if you become separated.
- If a stranger comes to your door beware!
 -Criminals sometimes pose as couriers delivering gifts
 - -unscrupulous people sometimes go door to door collecting for non-existent charities-ask for identification and how the funds will be used. If your not satisfied-don't give, Help a charity you're familiar with instead.


DUNWOODY NORTH GARDEN CLUB

BY-LAW CHANGES

At our October general meeting, those present voted to make a change in the

DNCA By-laws: Article IV Officers, Section 1.a which previously stated that the Association shall be managed and its affairs conducted by a Board of Directors which shall consist of the following: a. President, V. President, Recording Secretary, Corresponding Secretary, and Treasurer.

The change is to add a new V. President of Zoning which will henceforth become an elected position.

ANIMAL CONTROL ORDINANCE

The following is a brief summary of the Code of Dekalb County, Georgia, Chapter 5: Animal Ordinance Control:

An animal owner has a obligation to prevent animals from roaming free, protect others and their property from damage or injury by said animal, keep the animal restrained via leash, containment) while on or off the owner's property, or voice control (note: voice control only applies if the animal obeys said control on your own property only; to register all dogs and cats, and have them inoculated against rabies after the age of 3 months; all animals must wear a collar and ID tag at all times.

Implicit in the ordinance, is the **obligation** of animal owners to curb their animals and prevent them from unnating or defecating on other people's property. Be considerate of your neighbors-if you do not appreciate walking through animal droppings when mowing your lawn, please do not create the problem for your neighbors!

DEKALB COUNTY NOISE ORDINANCE

SECTION 16-46 NOISE of the county ordinance can be summarized as follows:

It shall be unlawful for any person to make, continue or cause to be made or continued loud, unnecessary or unusual sounds or noise which either annoys, disturbs, injures or endangers the comfort or repose, health, peace or safety of others in the county and which is audible at more than 50 feet from point or origin.

The following are considered to be loud or disturbing horns, such as automobile and the like, radios, phonographs, stereos, ctc., loudspeakers and amplifiers, yelling and shouting after 11 PM and before 7 am; animals and birds, e.g. constantly barking dogs; steam whistles; explosive exhaust discharges; the loud grating, grinding or rattling of any motor vehicle due to its load or state of repair; the loading and unloading or opening of boxes; etc.


We all know what constitutes loud intrusive noise into our peaceful community. Please keep this in mind in the upcoming holiday season and show consideration to your neighbors who may not want to party till all hours or appreciate your choice of music- it's both inconsiderate and illegal to impose it on them.

Remember, if it can be heard out in the street-it's too loud!

ENVIRONMENTAL HEALTH ISSUES: RATS

DO YOU THINK YOU HAVE SQUIRRELS IN YOUR ATTIC?...... THEY MAY BE RATS!

As the result of a number reported incidents of rats in homes on both sides of the subdivision. Gern Penn contacted the county division of environmental health and met with Mr. Bert Tyler to get some pertinent information. We have summarized, the information she received via printed material and conversation with Mr. Tyler:



Rats live in areas inside and around homes, such as basements, attics, crawl spaces, under piles of trash and stacks of wood, next to creeks and in wooded areas. Rats can enter a home in a variety of ways (see diagram).

It doesn't take much for a rat or mouse to gain entry into your house... a mouse only needs a minimum of 1/4" diameter hole, a rat needs a minimum of 1/2" diameter opening. If they can get their head in... they can squeeze their bodies in without any trouble.

Two types of rats are common in Dekalb County: roof rats and Norway rats. Roof rats tend to inhabit ceilings and attics while Norway rats generally settle in the lower levels of homes and basements. Evidence of rat infestations include burrowings,

droppings (check the top of water heaters, flooring and boxes in the attic), sightings, noises (scrabbling sounds in the attic) and sometimes there are chew marks.

Rats are attracted by leaving pet food outside, bird feeders, improperly contained trash, junked equipment, e.g. broken appliances, tires, etc. dense vegetation, even grass seed in garages and sheds. Be considerate of your neighbors...leaving food outside for animals can attract rats to your neighbors' property. Property damage from rats can be quite expensive and very impleasant to remedy.

In addition to all the entry points indicated in the diagram, access is also provided through pet doors and the vent space between the roof and the fascia board behind the gutters. Your homes' proximity to culverts, excavation on or near your property that disturbs the rats' nests, trees and shrubbery that overhangs your house and provides easy access to your roof- all contribute to the problem.

According to Mr. Tyler, there are no magic poisons and electronic devices are useless. <u>Note</u>: If you put poison in some food and the animal eats the food but doesn't die, you must change the food base the next time you put out poison because they'll never eat that food again-one trial learning (Editor's lab experience).

Mr. Tyler's department will provide free of charge information, inspections to check for rat infestation and points of entry, and they will put out poison for home owners. However, before you set out poison, consider the consequences if the animals crawls away to die within the walls, crawl spaces or deep in the attics. The smell of the dead animal is very penetrating, remains for a long time and decaying carcasses draw other vermin. Consequently, Mr. Tyler prefers trapping rats with the use of live animal traps or spring traps (at least the animal stays put that way). Although the county will not provide the trap to the homeowner-you must buy it yourself-they will pickup live animal traps and release them in a safe place and return your trap.

Some things the homeowner can do immediately are to refrain from leaving any source of food around, install 1/4" hardware cloth (actually heady duty metal screening) behind the gutters and attach to the fascia board, and keep garage and unscreened doors and windows closed at all times.

Before you close up or secure all other potential points of entry into your home, be sure to rid it of rats first! Another thing that homeowners can do is to hang socks filled with mothballs in the attic or basement crawl spaces-apparently, rats don't like this very strong smell-but then neither do we-so consider whether you have to access these spaces frequently yourselves before taking this approach.

Rats generate an average of 20 fecal droppings per day which are a source of Hanta virus, although there have been NO reported cases in the area. Rat bites can also result in Tetanus and rat bile fever. And remember, if you've seen one rodent, you can be sure there are more.

Dear Ms. Levetan:

This acknowledges receipt of the county's legislative package for the 1998 legislative session. I have reviewed it and find that based on the following I can no longer support any proposed legislation. Let me preface my remarks by stating that the payment of taxes is an investment in government and as with all investments, taxpayers must expect and demand an adequate return on that investment in terms of quality services, jobs and contracting opportunities. The residents of South DeKalb are not receiving an adequate return on the taxes paid to DeKalb County. Our streets are in disrepair, and my constituents constantly complain regarding the lack of respect and interest given South DeKalb interests by the county government.

Letters to you and department heads are not answered and citizens are treated rudely on the telephone. There is no plan for the development of South DeKalb except dumps, pauper's cemeteries and shouldy residential subdivisions.

I am very concerned regarding the low pay of our police officers. As you know, I featured this situation on my last cable program. I have also repeatedly requested that you and your department heads come on the program to discuss the HOST tax, but I always receive excuses despite the fact that you find time to attend media events in South DeKalb.

After you were first elected CEO, I met with you personally to discuss the deplorable conditions at the Scapstone Center for the Arts. You assured me in 1992 that the facility would move to a free standing building owned by the county. This has not happened.

My constituents are demanding that a disparaty study be contracted out immediately and that independent and outside counsel be retained to defend the county against any lawsuit resulting from attacks on the county's toothless affirmative active contracting program.

There are too many issues to list in this notice of dissatisfaction, but I am in the process of polling all of our community organizations, elected officials and community leaders to prepare a detailed list of county concerns. The days of our following along quietly are OVER.

The list goes on and on and as long as the South DeKalb legislative delegation serve at your beck and call nothing will happen.

Your immediate attention in appreciated.


