Gathering Information for the Dunwoody North Community

Summary:

The majority of calls received by the DNCA in the last year have been regarding zoning, Brook Run, Peachtree Dekalb Airport and neighborhood attractiveness. Your board met recently to discuss these issues and do some strategic planning. The DNCA is reorganizing to better service the community.

Reorganization:



The DNCA will be organized around three major topics which all impact our quality of life and our property values, 1) <u>The people</u> (i.e. Neighbor to Neighbor camaraderie and commitment), 2) <u>The property</u> (i.e. Visual attractiveness of the neighborhood), 3) <u>The politics</u> (i.e. Northeastern Dunwoody as part of the bigger picture that affects our Neighborhood.

We will also refocus the newsletter to reflect this approach. The newsletter will have a "President's Message" section, a "We the People" section, a "Manor Matters" and a "Maloof and the Gold Dome" section.

The "We the People" section will consist of "Announcements", "Neighbor to Neighbor", School Notes, Dunwoody North Driving Club Notes, and a "Neighborhood Watch Report" to address "the people" part of the strategic plan.

The "Manor Matters" section addresses the property part of the strategic plan. It will include the Dunwoody North Home and Garden Club Notes and reports on how to make our neighborhood more attractive.

The "Maloof and The Gold Dome" section will include "About Politics" which will focus on issues like zoning, Brook Run and PDK. It will include an "Information Digest" section and will address "the politics" part of the strategic plan. This month in "Information Digest" we focus on Community Council.

MANOR MATTERS

DNCA applauds the efforts of the Dunwoody North Home and Garden Club in their goal to reward neighbors that go above and beyond in keeping their homes attractive. We will be addressing ways to extend this approach in the future.

The county has very lenient codes for your house and property. The county codes are the absolute minimum of legal and moral responsibilities we all have to each other as neighbors. Even with that said, sometimes all of us get into situations beyond our control that prevent us from appearing to be good neighbors. The Association has always stayed out of these situations.

We have implemented a "Courtesy Letter" campaign out of necessity in the last couple of months. We have decided that the DNCA can't stay out of this and fulfill our purpose. Rather, we need to take a positive approach. Neighbors can call us to report a neighbor who appears to be unconcerned about the attractiveness of their property. DNCA will send a courtesy letter to them asking if we might be of help and alerting them to neighborhood

concerns. If the letter doesn't help then the neighbor has no alternative but to report issues to the county. Our code enforcement officer is Office Nichols (404-371-2776). If you will call us (770-455-8547) when you report to him, we can follow-up with him on issues periodically.

ABOUT POLITICS

Brook Run

Things seem to be stirring at Brook Run as the weather brightens and people begin to think about outdoor activities. I have heard from several of you that Dunwoody Homeowner's Association (DHA) was building a park at Brook Run (BR). DHA is not building a park at Brook Run.

Several DHA members (not the Board, although they might support such a plan) are pushing for a small playground park at BR in the interim until the county decides what to do. DNCA suggested this to Becky Kelly last year and would probably support that. We will be involved in any plans that go forward. I have heard from Becky Kelly (a year ago) and Elaine Boyer more recently that the (DNCA) will be kept informed. DNCA is critical to the success of anything at BR, as we are the largest organized group closest to BR.

Nick Nicodemus, the DHA Chairperson for Brook Run, is a DNCA neighbor. In addition, DHA has just offered me a position on their board, which should facilitate communication on many issues even further. Nick has worked with the Sheriff's Department and Public Works in utilizing trustees to clean up some of the trash in BR and haul off much of the refuse. They will continue this until finished or plans are forthcoming from the county. If you see him, thank Nick for organizing this.

Peachtree-Dekalb Airport (PDK)

Contrary to the critics' exclamations, we are not proposing PDK go away. It is our airport. It is a neighborhood airport for private pilots and some business planes. We want it to stay that way. For the most part, those already using the airport don't fly at night when we are trying to sleep. But soon you will be able to get jet service to New York from PDK. We don't know what hours they will fly. Some things to ponder are why did one man obtain land leases at PDK as a principle in several different companies? How was the lease to build a new hanger

and another lease for a hotel at PDK acquired from Dekalb County by the same man on an unsolicited, noncompetitive basis? Why does the county and the CEO continue to tell the neighborhoods that PDK will not expand when it obviously is expanding? Does selling individual seats on a plane over the Internet meet the definition of commercial flights? You have one man making money off PDK at your expense. We are working to get all the groups monitoring PDK together to form a united front.

INFORMATION DIGEST:

Zoning Community Council

Have you ever wondered how land gets re-zoned? Do you wonder if anyone has the surrounding homeowner's interest at heart? If something new was proposed next to our neighborhood would anyone know?

Dekalb County asks homeowners to participate in this process. A group of volunteer neighborhood homeowners meets once a month to listen to proposed zoning or land use changes in their area. These members do not have special qualifications, except that they are homeowners who care about what is happening around their neighborhood. Areas are broken up by County Districts. Dunwoody North has four representatives in the Community Council. This is good representation for our neighborhood and a great benefit to us as homeowners.

Here's how the process works, in brief. Developers or builders propose zoning or land use changes to the county. An agenda is mailed to all Community Council members. Members meet and listen to the proposal and any comments from the public and neighbors. Most members are committed to making sure that the neighbors know and approve of the new proposal, that the proposal includes conditions the neighborhood wants or needs (i.e. sidewalks, tree buffers, parking for visitors etc.). It is interesting and sometimes volatile. The Community Council votes to recommend approval, denial or deferment. The vote can, and usually does have conditions.

The next step is the Planning Commission. This is also a public meeting. The different administrative departments meet with the developer/builder and discuss their requirements.

The final step is the Board of Commissioners meeting. This, too, is a public meeting. The Commissioners listen to the proposal and opposing or agreeing views. They review the Community Council's recommendation as well as the Planning Commission's recommendation. The Commissioners vote on the rezoning.

The May, 2000 Community Council meeting did not review any zoning changes that immediately affected our neighborhood. The closest proposal was off Winter's Chapel Road, near some of the new neighborhoods recently built there. A plan for 52 townhomes was recommended for approval with conditions.
