Peachtree DeKalb Airport Expansion & Noise Abatement

Mr. Carl L. (Lee) Rimmel, A.A.E., Airport Director and Mr. Mario A. Evans, Noise Abatement Specialist will respond to written questions and concerns compiled and transcribed from October 12, 2000 DNCA Meeting with Mr. Rimmel. The weight limit for aircraft at PDK is currently 75,000 pounds and the director may approve up to 105,000 pounds in the future. See inside for details.

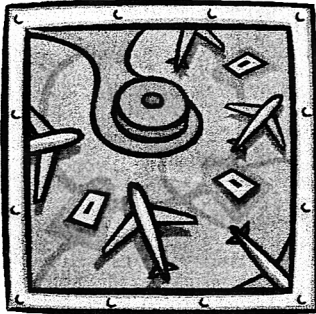

Written questions presented to PDK Airport Director, Lee Rimmel which will be answered at the May 15th Meeting

VOLUNTARY CURFEW 2300 HRS TO 0600 HRS IS INEFFECTIVE

If services were not provided during the curfew, do you agree, aircraft not based at PDK would have little or no reason to land? Who owns, operates, and/or are the principal stockholders in companies providing fuel and food at PDK during the curfew? Are any checks being made on aircraft violating the curfew? What? Are all violators of the voluntary curfew reminded as they approach the airport of the curfew? Is the airport still only sending out letters to the violators reported by citizens? If so, why? What has been done to encourage cooperation with the voluntary curfew? What can be implemented to require flight plans to be filed by all aircraft utilizing PDK during the curfew?

INCREASE OF JETS

You stated in a letter to Gerri Penn dated November 2, 2000 "the average number of operations per year is 226,127 from 1980 through 1999. What percentage of the operations were jets in each of those years? What number of the aircraft exceeded 66,000 pounds during each year?

WEIGHT LIMITS

When and by what authority was the weight limit of aircraft utilizing the facilities at PDK increased from 66,000 pounds to 75,000 pounds? In January 1999, it is my understanding you, Director Carl Lee Rimmel, attempted to raise weight limit up to 105,000 pounds. Currently the "aircraft limited to weight under 75,000 pounds unless Airport Director allows higher weight. Under what circumstances do you allow weights over 75,000 pounds to land at PDK? What is the procedure to obtain this permission? What amount of time is required to obtain your permission? How many aircraft exceeding 75,000 pounds landed at PDK during January 2001? How many were during the voluntary curfew?

NOISE ABATEMENT HOT LINE

If Noise Abatement Officer looks up the offending aircraft to file a complaint, why is that information not provided under GORA when a call back is requested? Why are call back requests routinely ignored?

NOISE

Sec. 16-46 of DeKalb County Code, Noise: "It shall be unlawful for any person to make, continue or cause to be made or continued any loud, unnecessary or unusual sound or noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others in the county, and which is audible to a person of normal hearing, ability more than fifty (50) feet from the point of origin of the sound or noise." Jet aircraft are "blowers" as defined in Item 16 of the enumeration of noises declared to be in violation of the ordinance. As plotted by Mr. Rimmel I am approximately 3 miles from PDK, aircraft should be at 1100 feet. Frequently I am awakened in my home (with storm windows and extra insulation in walls and attic) by an aircraft during the curfew.

STATEMENT OF POLICY

The DNCA wants to see the integrity of our community maintained and therefore promotes anything that will improve the value of our homes. DNCA feels that in order insure the above goal, we want all residents to abide by the codes of Dekalb County.

If any resident has a complaint about a home in our community he/she needs to follow the following process: Contact the neighbor first. If you cannot get the situation resolved with your neighbor, then call Code Enforcement at 404-371-2776 or 404-371-2118 and report the problem to them. Please keep a record of the date you called, who you spoke to, and what they say. You might want to also send a letter to confirm your conversation. Give them about three or four weeks and then call for an update if you don't see any changes at your neighbor's home. If you do not get any results, please contact Gerri Penn in writing only to her at 2714 Amberly Way, Doraville, GA 30360. Please give as much information as possible in your letter. The Civic Association will then intercede by contacting one of the Code Enforcement Officials. DNCA does not support applications for variances to the Dekalb county codes.

COMMON CODE VIOLATIONS IN OUR COMMUNITY

The following list is comprised of the most common complaints that we have received in the past few years. Yard is not maintained and there is overgrowth of grass and/or weeds (unraked leaves fall into this category), Too many cars on street or driveway, Junked cars, Open storage in carport, front porch, or in front yard, Barking dogs (a violation of the county Noise Law), Loose dogs and cats (it is required for poop to be scooped up by dog owner, and both dogs and cats fall under the leash law), House in disrepair i.e. in need of paint, falling apart, In-home businesses with customer contact and/or signs.

Please be advised that if you are adding on to your home or building an accessory structure in your backyard, you need to get a permit. You cannot build a freestanding structure in your front yard. Please remember that Dekalb County also has a Tree Ordinance.

CITIZEN'S DEPUTY PROGRAM

Ernie Blow, the Director of the Code Enforcement, is reinstating the Citizen's Deputy Program. Citizen's will go through training and then be able to drive through neighborhoods to write up violations like tall grass, open storage, and junk cars. Citizens would not have to leave their cars to do this. For more information, please call Mr. Ernie Blow at 404-371-2776 and ask for the information concerning this wonderful program. Zoning Issue

Dear Members of the Community,

On March 22, 2001, the Board of Commissioners deferred a vote for 60 days on an amendment to the Zoning Ordinance of Dekalb County. If this amendment #01003 is passed it can affect all neighborhoods in Dekalb County.

If this amendment is enacted all PLACES OF WORSHIP* in existence before April 13, 1999, will be able to develop their property with absolutely no notice to the surrounding neighborhood, and with no public hearings required. Neighborhoods in Dekalb County would have no input when these institutions decide to expand or develop their property. A petition to defeat this amendment will be available at the DNCA meeting and if you would like to canvas your neighbors for signatures, petitions are available from Mrs. Gerri Penn at 770-457-2474.

You may keep a log and call on a weekly basis or request a call back. Mr. Mario Evans, the new Noise Abatement Specialist is implementing new procedures and working with the community.

IT'S EASIER THAN EVER TO JOIN FOR FIRST TIME MEMBERS

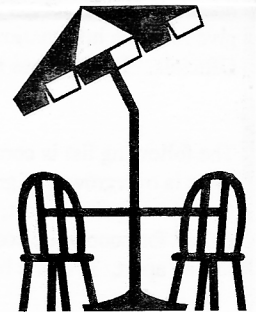
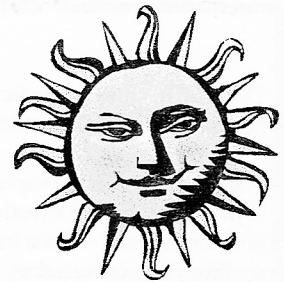

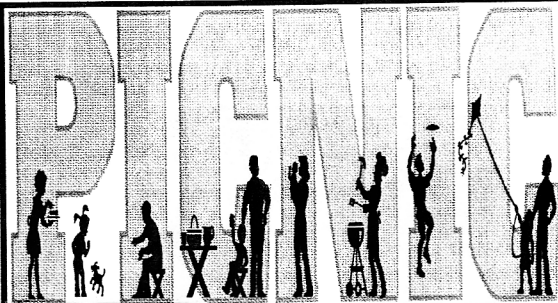


DNDC Clubhouse Rental Information

All students, new and returning, need to provide proof of residency, e.g., a current utility bill. New students will also need immunization, hearing and dental forms. All forms can be obtained from the school.

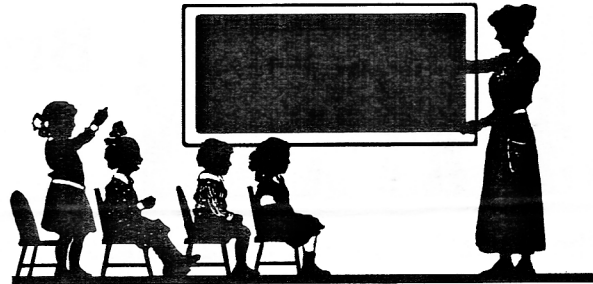
Kindergarten Roundup

Neighborhood Watch

MAN ARRESTED FOR BURGLARIES - After 3 break-ins from January 12 to February 21, 2001, a man was apprehended in the process of burglarizing at Post Apartments. He admitted to 15 burglaries at Post, but would not admit to the ones in Dunwoody North. Things have been quiet here since his arrest, however, we must stay vigilant because it is believed there are others involved.

REVERSE 911

A communication system designed for quick dissemination of urgent information (such as crime alerts, hazardous material spills, scams, etc.) to a large population. When Public Safety authorities determine a message should be issued to the public in a certain area, the R911 system is programmed to call the residents and deliver the recorded message. If you have an unlisted telephone number and would like to have your name added to the R911 database, call Charles Delk at 770-604-3928. **Remember, if you receive a recorded message that begins, "This is a DeKalb Police Bulletin," please DON'T HANG UP!**

Sex Offenders- The State of Georgia operates a web site (<http://www.ganet.org/gbi/sorsch.cgi>) containing a "Sexual Offender" list which you can access to identify any sexual offenders living very near our neighborhood. Once you are on the web page, enter your zip code and you will find that there are addresses as close as Peeler and Dunwoody Place.

Home Security Survey - The Crime Awareness Officer for North DeKalb Precinct, Charles Delk, (770-604-3928) will gladly arrange a **free home security survey** to identify any areas (such as locks, doors, windows, lighting, shrubbery, etc.) that may need security improvements. His standard security statement to us is still, *"Always report anything suspicious, that is anything out of the ordinary, to 911 immediately."*

Alarm Systems - PLEASE operate your alarm system with care to avoid setting off a false alarm: make sure you are thoroughly familiar with the operation of your system; that you keep it properly maintained; that you secure all your windows and doors when you leave; and that you insure that your pets cannot activate the system. The police receive hundreds of false alarms for every valid call reported. Let's make sure every call they receive from the Dunwoody North Community is valid. Remember, **you are the key** to the security of our community.

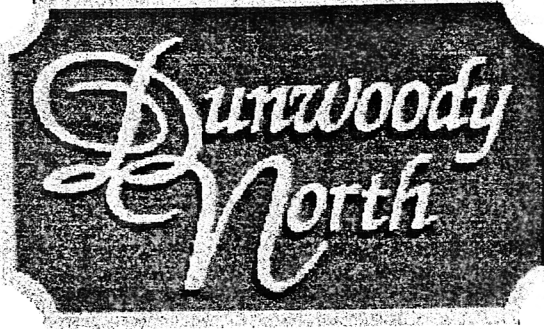

Scott Candler Water Filter Plant Reservoir Expansion

DeKalb County's current raw water storage from the Chattahoochee River consists of two reservoirs adjacent to Peeler Road. The capacity is 240 million gallons (MG) which is sufficient to supply the system for 3 average days or for 2 dry summer days. Construction will begin this fall to increase the storage at the two existing reservoirs plus add a third reservoir across Winters Chapel Road for a total capacity of 1 billion gallons. This should be sufficient for over 9 average days or 5 peak days at the county's current estimated build-out. The project will consist of moving over 1.5 million cubic yards of earth and will cost an estimated \$60 million. The construction, which will be phased in order to provide at least 240 MG of water at all times, is estimated to be complete in the fall of 2003.

Scott Candler Water Filter Plant Expansion

The Scott Candler Water Filter Plant, DeKalb's only water plant, was initially constructed in 1942 and has been expanded a number of times to its current 128 million gallon a day (MGD) capacity. While the plant has served the County well these 50 plus years, in order to upgrade to the newest treatment technologies available, a new water plant is necessary. The proposed new plant will be constructed next to the current plant on Winters Chapel Road.

The construction will be completed in two stages with the first stage consisting of: 1) automated solids handling facilities; 2) ozonation for disinfection, the treatment of microorganisms, and the reduction of disinfection by-product; 3) all new sedimentation basins and deep bed filters; and 4) backwash water treatment and recycling. Overall treatment capacity will be expanded in this first phase from 128 MGD to 150 MGD. This is expected to serve the needs of the County until at least the year 2020. The 150 MGD expansion would, to the fullest extent possible, anticipate a final expansion to 200 MGD. All structures and associated piping will also be designed to accommodate 200 MGD. The final expansion would be done around 2015, to a maximum capacity of 200 MGD. The 200 MGD expansion is anticipated to provide ample water supply for the County at build-out.

The cost of the 150 MGD expansion is estimated at \$175.5 Million; the final expansion to 200 MGD would be an additional \$50 million. The project is scheduled to begin 4 months after initiation of the reservoir expansion project. Brook Run Update from the Dunwoody Preservation Trust

To date the Dunwoody Preservation trust has not received any of the \$150,000.00 grant approved by the DeKalb County Board of Commissioners. The committees are in place and ready to move forward immediately upon receipt of the funds.
