#### **Article VI - Duties of Officers**

Section 3 Vice President of Zoning and Code Enforcement

- 1. Shall chair the Zoning Committee
- 2. Shall notify members of zoning issues
- 3. Shall support the community with Code Enforcement issues in accordance with the established Association policy.

My husband, L.C. moved to Doraville on Jan. 3, 1940 when it was just a small farming community. North Peachtree St. was unpaved and his house was where Peachtree Charter Middle School is today. He attended Doraville Elementary School

and Chamblee High School for two

years.

I moved to Brookhaven in 1945 and attended Chamblee High School for two years. L.C. had already graduated and came back to school one day for a visit. When I met him I thought he was the most handsome young man I had ever seen and I still do.

We married on October 9, 1948 and we recently celebrated our sixtieth wedding anniversary.

On May 26, 1957 we moved into our new home in Doraville. L.C. subcontracted it out and he and his carpenter father did a lot of the work themselves. We moved in with two little girls and in a few years had two more little girls. L.C. always said that all his boys were girls.

L.C. owned a service station and car repair shop for forty years at the corner of Cheshire Bridge and LaVista Roads. I was a homemaker.

Chamblee changed from a farming community to a thriving town and our part of Doraville became Dunwoody.

> Fifty-one years later we still live in the same house and I would not change it for all the mansions in the world.

> We have memories that will last a lifetime. We had wonderful neighbors. There were friends for the girls, we had a basketball goal, pizza and cokes for all the neighborhood kids and every parent knew where

their children were. Three of our original neighbors still live here.

We now have four daughters, nine grandchildren, four sons-in-law, a grandson-in-law and two adorable little great-grandchildren. We have been blessed beyond measure.

Here are some happenings in 2008. On December 15 the DNCA held its annual luncheon at the North Precinct in honor of the police officers who serve in our area. Carrabba's Italian Grill at Ashford Crossing graciously delivered the delicious food. It was an occasion for a soon-to-be fond farewell. The new Dunwoody Police Department is expected to be up and running by April 1, 2009.



You probably read in the local newspapers and the AJC, reports of the rash of burglaries that occurred in our neighborhood over the months of July to November. The suspected burglar has been arrested and taken to jail. He was renting a room at a house on North Peachtree Road.

Here are a few items to report. Over the holidays, inflatable decorations were cut in a front yard on E. King's Point Road. Two suspicious cars were reported. An American flag was stolen from a front porch. No home break-ins were reported to me during this holiday season.

# **Zoning and Code Enforcement**

Fortunately, we have not dealt with Zoning issues this year. There have been numerous Code Enforcement issues. Vigilant neighbors reported many things to Code Enforcement and the Civic Association.

Home Occupations are still a problem. If you operate a business in your home, there must be no customer contact, no employees, no trucks or equipment at the house unless contained in the house or in a unit no more than 900 square feet in the backyard, no open storage.

Over the years, we have had numerous complaints about rental properties. As you know, the recent arrest of an alleged Dunwoody burglar, revealed he was renting a home in Dunwoody North. If you are thinking of renting your home, please consider getting both a background and credit check of the renter. If you are renting your home to more than one person, please check all of your tenants. Your home is in a community so please be a good neighbor to those who are living here. Please make sure that your property is being maintained.

Our policy still remains the same for reporting Code Violations as can be found on the Dunwoody North web site at www.dunwoodynorth.org.

#### Below are some answers to frequently asked questions:

My dues of only \$20 are a very good investment, but how does DNCA spend the dues we collect?

100% + of your dues are spent on community projects and disseminating information to our members. This sounds impossible but it's true because we collect revenue from ads in our newsletters, in our directory and on our website. This, plus all the volunteer hours from the directors and other members, allows us to spend more than we collect from dues to improve our community, provide you information and support worthwhile charities and organizations.

Of the total dues collected in the last two years, we spent:

43% to print and distribute four newsletters

32% to print and distribute the neighborhood directory

23% for Neighborhood Watch automated calls

19% for community service, e.g., appreciation lunches for our police officers and fire fighters

15% for public information records from governmental agencies to review and "encourage" officials to follow laws and properly complete projects at Peachtree Middle School and Brook Run.

7% for beautification and improvements to the community

4% to host our dunwoodynorth.org website

1% for other expenses

#### That's 144% of the dues collected.

Thanks to our neighborhood real estate professionals and other local business owners who purchase ads that allow your dues to do more.

#### Which neighborhoods does DNCA serve?

In addition to Dunwoody North, DNCA serves residents in Andover Estates, Laurelwood Farms, Dunwoody Trails, Brafferton Square, Briers North and all three Madisons.


# Fire Station 18 Holiday Luncheon

Dunwoody North Civic Association partnering with Serendipity Catering provided a luncheon for all three shifts of DeKalb County's Fire Station 18 on January 8th, 2009.

Renate Herod chaired the committee and had the help of Bobbi Sedam, Leslie O'Callaghan, and Gerri Penn. Arrangements for this luncheon were made with Captain Kyle Bradshaw of Station 18. We enjoyed the opportunity to show our appreciation for the awesome service that this Fire Station provides for our entire neighborhood.

Station 18 is located on Barclay Dr., next to Brook Run Park. The station maintains a daily, round-the-clock operating staff of eight personnel per shift. The apparatus that is staffed daily includes: Truck, Engine and Advanced Rescue.

The Rescue truck is staffed with a Fire Medic around the clock and provides life support to citizens. Station 18 also has a Hazardous Materials-Decontamination Specialty Team. The "Decon" truck is housed at the station, ready to activate when dispatched to an incident.



On the grounds of Fire Station 18 there is a DeKalb County paper recycling bin that any DeKalb resident may use. There is also an area for the collection of aluminum cans. The proceeds from the sale of the cans go to a charity for treatment of burned children and especially for a summer camp serving children recovering from burns.

The station is open every day and neighbors may stop in during the day for a blood pressure check or to have their child's car seat properly installed.

The firemen gave us a tour of the station which includes a fully equipped kitchen, exercise room (all equipment was donated), dorm room, TV area, dining area and truck bay.


We were impressed with the professionalism, team spirit, self-sufficiency and hospitality of the firefighters. They also showed off their ability cook, do dishes, clean up and store the leftovers in record time.

Battalion Chief Leslie Clark came to our luncheon and we were made to feel like honored guests. The firemen told us how much they like being stationed in Dunwoody and asked us to tell all the neighbors they are welcome to stop in any time.

# **Property Tax Information from the City of Dunwoody**

If you have already filed for a homestead exemption and/or property Freeze with DeKalb County and currently have the exemptions in effect, the City will grant the exemptions on your municipal property tax.

However to be abundantly cautious, the city of Dunwoody is asking homeowners to submit an application directly to the City of Dunwoody for the same exemptions and/or property tax freezes you have enjoyed over the years.

Applications are accepted year round, but in order to quality for exemptions this calendar year, you must apply by March 1, 2009.

You can look up your property address to see your parcel identification and pin numbers and to see if it says you have the exemption. Visit this website:

Once you are on the site, if you need more application forms, click on 2009 Homestead Exemption Application. Click on the Supplemental Exemption Application (for citizens over 65 with income less that \$15,000 per year), if you need that application form.
